6. You will pay to our client costs at such amount to be assessed by the Court, if not agreed.


Our client will also require you to execute a Deed of Undertaking to the above effect.

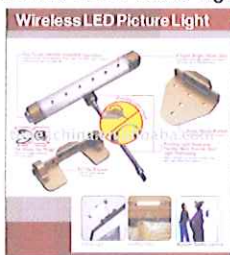
